Module 5 : Information Management

Duration: 30 hours (Knowledge) + 15 hours (Revision)

This module provides students with an understanding of the overall legal framework in which businesses in Hong Kong operate to enable them to analyse and apply the relevant laws and applicable to business problems.

Key Topics :

- The role of e-Commerce
- The risks and security of information management
- The nature and account for the value of information systems
- Corporate information systems
- Systems development process
- Information technology applications

Module 6 : Financial Accounting

Duration: 30 hours (Knowledge) + 15 hours (Revision)

This module develops students' knowledge and comprehension of the accounting standards in accounting for business transactions and in preparing financial statements, including simple consolidated financial statements.

Key Topics :

- The framework of financial accounting and reporting
- Appropriate accounting principles and concepts to account for business transactions
- Financial statements in accordance with Hong Kong Financial Reporting Standards
- The accounting principles and concepts to prepare financial statements with simple group structures

Module 7 : Financial Management

Duration: 30 hours (Knowledge) + 15 hours (Revision)

This module provides students with financial management principles and techniques in providing business information to management for the purposes of planning, control, performance evaluation and decision-making.

Key Topics :

- The financial environment in which businesses operate
- Financial risk framework and different methods of managing financial risks
- Pricing strategies and decisions
- The strategic management accounting framework
- Produce financial analysis
- Consider and apply information for effective performance measurement
- Different sources of finance and capital structure
- Appraisal techniques for capital investment projects
- Produce financial forecasts and evaluate business plans

Module 8 : Principles of Auditing

Duration: 30 hours (Knowledge) + 15 hours (Revision)

This module provides students with an understanding of the regulatory, legal and reporting framework of auditing in Hong Kong and an understanding of the basic principles of auditing.

Key Topics :

- The professional standards and guidelines applicable to an audit
- The nature and purpose of auditing
- Audit approach and planning
- Audit procedures to an audit
- Auditor's report

Module 9 : Principles of Taxation

Duration: 30 hours (Knowledge) + 15 hours (Revision)

This module provides students with an overview of the Hong Kong tax system and the ability to advise on simple tax matters and prepare straightforward tax calculations.

Key Topics :

- The tax system and administration in Hong Kong
- Tax rules and principles and calculate tax liabilities for property tax, salaries tax, profits tax, personal assessment and stamp duty in Hong Kong
- Profits tax rules and principles and calculate profits tax liabilities for cross-border transactions

Module 10 : Business and Company Law

Duration: 30 hours (Knowledge) + 15 hours (Revision)

This module provides students with an understanding of the overall legal framework in which businesses in Hong Kong operate to enable them to analyse and apply the relevant laws and principles applicable to business problems.

Key Topics :

- Corporate laws and regulations
- The legal system and the key roles of external regulatory bodies in Hong Kong
- The law of tort and negligence
- Key concepts and principles of the contract law, the consumer laws, the employment laws
- The key concepts and principles of the bribery and corruption laws
- Agency relationship
